2023 Membership Descriptions

Individual Golfing

An Individual Golfing Membership entitles one individual full use of the golf course, practice facility, putting green, locker rooms, tennis courts & fitness room. Members will receive reciprocal privileges at all other Resurrection Properties. Family Pool add-on is available at an additional fee.

Couple Golfing

A Member and that Member's Spouse – either legally married or unmarried adults residing in the same household - who acquire a Couple Golfing Membership are entitled to full use of the golf course, practice facility, putting green, locker rooms, tennis courts & fitness room. Both members will receive reciprocal privileges at all other Resurrection Properties. Family Pool add-on is available at an additional fee.

Family Full Membership

A Family Golfing Membership entitles a Member and that Member's family - either legally married or any two unmarried adults residing in the same house, and their unmarried children under the age of twenty-five (25) to use the full use of the golf course, practice facility, putting green, locker rooms, pool complex, tennis courts, & fitness room. All members will receive reciprocal privileges at all other Resurrection Properties.

Young Adult Golfing

An Individual Membership entitles one individual age 25 to 35 full use of the golf course, practice facility, putting green, locker rooms, tennis courts & fitness room, as well as reciprocal privileges at any club owned and/or operated by Resurrection Golf. A Young Adult Membership shall terminate at the end of the season upon reaching the age of 36. Family Pool add-on is available at an additional fee.

Young Adult Couple Golfing

A Member and that Member's Spouse - either a legally married couple, or any 2 unmarried adults residing in the same house - who acquire a Young Adult Couple Golfing Membership and are age 25 to 35 are entitled to full use of the golf course, practice facility, putting green, locker rooms, tennis courts & fitness room, as well as reciprocal privileges at any club owned and/or operated by Resurrection Golf. A Young Adult Couple Membership shall terminate at the end of the season upon reaching the age of 36. Family Pool add-on is available at an additional fee.

Senior Golfing

A Senior Individual Golfing Membership entitles one individual of age 60 or greater, full use of the golf course, practice facility, putting green, locker rooms, tennis courts & fitness room, as well as reciprocal privileges at any club owned and/or operated by Resurrection Golf. Family Pool add-on is available at an additional fee.

2023 Membership Descriptions cont.

Law Enforcement Office / Military Golfing

An LEO/Military Individual Golfing Membership entitles one individual, retired or active duty, full use of the golf course, practice facility, putting green, locker rooms, tennis courts & fitness room. Members will receive reciprocal privileges at all other Resurrection Properties. Family Pool add-on is available at an additional fee.

Social Memberships

An Individual or Couples Social Membership entitles the Members to use all the facilities of the Club, except for the golf course. Golf privileges will be available at the member's guest rate to all social members. Social Members will not be eligible for Club tournaments and league play.

Family Pool Add-On Members

A Family Pool Add-On Member entitles the Members access to the Old Marsh Pool and the opportunity to utilize the locker rooms. A Family is defined as either legally married or any two unmarried adults residing in the same house, and their unmarried children under the age of 25. Pool Members will not be eligible for Club tournaments and league play.

Corporate

College Student Golfing

A College Student Membership is a restricted membership that allows full-time students up to the age of 25 years to utilize the full use of the golf course, practice facility, putting green, locker rooms, tennis courts & fitness room, as well as reciprocal privileges at any club owned and/or operated by Resurrection Golf. Family Pool add-on is available at an additional fee.

Homes of OM Resident Social

OM Resident Social Membership is defined as one generation up and down, and grandchildren. Resident Social Membership includes the use of the swimming pool complex, practice facility, putting green, locker rooms, tennis courts & fitness room. A. MEMBERSHIP

The membership created by this Membership Agreement is a Membership at the Semi-Private Old Marsh Country Club, located at 445 Clubhouse Drive, Wells, ME ("the Club"), in the membership category set forth above. Membership is a revocable license to utilize the Club and its facilities and amenities, subject to the terms and provision of the Club's Membership Plan and Rules and Regulations as they may be amended from time to time. The Member acknowledges that Membership at Old Marsh Country Club is expressly "non-equity" and that no equity interest, ownership interest, vested interest, or prescriptive right or easement is created by this Membership Agreement, and that Member's Membership is not an investment in the Club, its facilities and amenities, or its business operations.

B. DUES AND OTHER CHARGES

All charges for food, beverage, goods, services, and other items may be charged to the Member's membership account and billed to the Member's pre-approved credit card monthly (this is optional). Member agrees to pay all membership dues and all charges, in accordance with applicable sections of the Membership Plan and Rules and Regulations. Member is liable for all charges incurred by family members and guests. Spouses (or unmarried couples) are jointly and severally liable for all dues and charges incurred by each other.

C. RECEIPT AND REVIEW OF MEMBERSHIP DOCUMENTS

Member acknowledges receipt and review of a complete Membership Package, including the Membership Application, the Membership Descriptions, and the Rules and Regulations. Member has had adequate opportunity to read and review such materials and to consult with such professional advisors and/or third parties as Member deems necessary, and Member agrees to be bound by the terms and provisions thereof as they may be amended from time to time. Finally, Member acknowledges that Member's decision to apply for and acquire a Membership has not been influenced by, nor has Member relied upon, any verbal representations of any Club representative.

D. CONSIDERATION

The consideration for this Membership Agreement is the annual fee paid by the Member and the mutual covenants set forth in this Application, and the parties agree that such consideration is good, sufficient, valuable, and non-refundable.

E. INDEMNIFICATION

Member acknowledges that the use of facilities, and any privilege or service incident to Membership, is undertaken by Member with knowledge of the risk of possible injury. Member agrees to accept all risk of injury to Member and Member's family members and guests which may be sustained while using the Club facilities or involved in any event or activity incident to membership. Member further agrees to indemnify the Club and to hold the Club (and its managers, directors, officers, principals, employees, agents, and other representatives) harmless from and against any loss, cost, injury, damage or liability sustained or incurred by Member, Member's family members, or Member's guests resulting from or arising directly or indirectly out of any conduct or event or omission connected with Membership in the Club and/or use of any Club facilities.

F. MISCELLANEOUS

This Membership Agreement shall be construed under the laws of the State of Maine and supersedes all previous agreements relating to membership or playing privileges at Old Marsh Country Club. The issuance of this Membership is expressly conditioned upon the affirmative acceptance by the Club of Member's Application for Membership, notwithstanding the execution of this Membership Agreement on date(s) set forth below, and by payment by Member in full of the requisite fee.
